

PATRON BARRING GUIDE BY-LAW

The Wests Group Australia has a duty of care to ensure the safety of its members and guests whilst on Club premises. The Wests Group Australia will not tolerate the following behaviours:

UNACCEPTABLE BEHAVIOUR	MINIMUM BANNING PERIOD
Swearing + Continued Offensive Behaviour	3 months
Argumentative / Quarrelsome Behaviour	3 months
Incident involving RSA Concerns / Refusal of Service	3 months
Theft from the club or another patron - under \$100	3 months
Failure to Quit / Move On	3 months
Theft from the club or another patron - under \$500	6 months or Until Debt Repaid
Theft from the club or another patron - over \$500	12 months or Until Debt Repaid
Inappropriate Conduct	6 months
Misuse of Membership Card	6 months
Breach of Barring	6 months for each offence
Suspected Use of Illicit Drugs on Premises	12 months
Breach of Self Exclusion	12 months or until Self Exclusion Expires (whichever is greater)

Harassment, Intimidation or Stalking of Staff / Patron	12 months
Failure to Follow Reasonable Direction of Manager / Police	12 months
Unlawful Entry to Club	12 months
Incident Involving a Minor	12 months
Threats / Aggressive Behaviour / Intimidating Behaviour	2 Years
Misuse or Supply of False Identification	2 years
Threat/ Intimidate with use of Weapons	3 years
Violent / Intimidating Behaviour	3 years
Assault / Altercation Causing Serious Injury	Life
Malicious Damage or Vandalism to Property	Until Debt Repaid + 6 Months
Breach of Wests Gaming Rules of Play	12 months

The Wests Group Australia reserves the right to change, combine or remove barring periods at any time. NSW Police may also issue penalty notices to persons separate to any Club disciplinary action.
